You also warrant and represent that this Agreement does not conflict with any agreement or understanding to which you, or the artists you may represent are bound, and that all of the Recordings, Clips and Materials, including all artwork, metadata, videos, trademarks and any other materials furnished by you to MusicIP shall not infringe on the copyrights or other rights of any person or entity.
